# photographer agency contract

Date: .....

THIS AGREEMENT DATED ..... BETWEEN ADAMS PICTURE LIBRARY, hereinafter called the Agency, and ..... hereinafter called the photographer, provides that:

1. The Photographer appoints the Agency as exclusive agent for marketing his/her photographs throughout the world except for the territories here listed:.....
2. The Agency shall have complete authority to act on the Photographer's behalf in all matters relating to the photographs placed with them including negotiation of fees and rights.
3. The photographer warrants that all photographs placed with the Agency are his own exclusive property and copyright and that a model release is available unless stated to the contrary on the photographs or mounts.
4. In the event of any claims whatsoever being made against the Agency from the subject matter of the Photographer's photographs, subsequent to the Agency offering them in the ordinary course of business on the Photographer's behalf will indemnify the Agency fully against any such claims.
5. The Agency's rate of commission is fifty per cent (50%) of all moneys received by the agency as revenues earned by the Photographs placed with the Agency by the Photographer. The agency will settle quarterly in respect of all relevant paid up accounts.
6. Whilst every care will be taken, the Agency cannot accept any financial responsibility whatsoever for the photographs left in their possession by the Photographer, or for any of these photographs left by the Agency or delivered to the possession of their clients. The Agency's Terms and Conditions of the business assign the responsibility to the client whilst in the clients possession and until their safe return to the Agency. The Photographer agrees to insure himself against loss of his Photographs whilst with the Agency and loss of ongoing income therefrom.
7. Any photographs deposited with the Agency by the Photographer will be retained by the Agency for a minimum period of 60 months from the date of their deposit. Thereafter photographs may be withdrawn on the giving of 12 months notice in writing, subject to their having been deposited in the Agency for at least 60 months, or as mutually agreed. All reasonable costs incurred in withdrawing photographs from the Agency files are chargeable to the Photographer's account. It is understood that termination of this agreement is without prejudice to all current negotiations that the Agency has properly entered into with any third party.
8. In the foregoing seven paragraphs the word "photograph(s)" shall include transparencies, prints, negatives or other illustrations where applicable.
